

## **Code of Conduct**

- 1. No using physical force, obscene language or gestures, racial, religious or ethnic slurs which are likely to create a disturbance or impinge on the hearing or speech of other patrons of Shadow Lake Town Center (SLTC).
- 2. No physical or verbal threatening of any person, fighting or disturbing others, noisy or boisterous activities or by following another person thru SLTC or by using sexually explicit language or conduct or in any other way creating a disturbance which interferes or endangers any SLTC patrons of its commercial function.
- 3. No running, skating, skateboarding, bicycling, obstructing or interfering with the free flow of pedestrian traffic or with other patrons view of windows and other tenant displays or assembling for the purpose of disturbing the peace or committing any unlawful acts.
- 4. No creating litter, throwing, discarding or depositing any paper, glass, gum, cigarettes or any other matter of any kind on SLTC property except in designated trash receptacles.
- 5. No defacing, damaging or destroying any personal or real property constituting part of or located at SLTC and belonging to SLTC, its patrons or its tenants including writing, spraying scratching or otherwise affixing graffiti on such property.
- 6. No yelling, screaming, singing, playing of musical instruments, radios, or otherwise of sufficient volume to impinge of the hearing or peace of other patrons unauthorized by SLTC management.
- 7. No engaging in non-commercial expressive activity without proper prior written permission of SLTC Management.
- 8. No parking in non-designated areas, including but not limited to, drive lanes, service areas or side-streets.
- 9. No soliciting money, contributions or disturbing commercial advertising/materials of any kind or offering samples of items which are sold or available for exchange for a donation or contribution.
- 10. No failing to be fully clothed or wearing apparel which is likely to provoke a disturbance or embroil other groups or general public in open conflict.
- 11. No sitting on floors, planters, handrails, stairs, fireplaces or trash receptacles.
- 12. No possessing any open can, bottle or other receptacle containing any alcoholic beverages except in areas specifically designated for alcohol consumption by those of legal drinking age. Outside alcohol is prohibited.
- 13. No Loitering, delaying, lingering or remaining idle at SLTC without any useful reason for being present.
- 14. No photographing or videotaping the interior or exterior of SLTC for commercial or scholastic purposes without permission from Management.
- 15. No engaging in any unlawful activities or behavior.
- 16. No carrying or possession of any firearms, simulated firearms or weapons of any kind openly or concealed with or without a permit anywhere within SLTC. Only exception is for transporting a purchased item between Dick's Sporting Goods and patron car.
- 17. No damaging, destroying, removing anything or inserting any foreign object or substance into any fountain or fireplace at SLTC.
- 18. No participating in group tours thru shopping center businesses for organized recreational games (i.e. scavenger hunts and similar activities) where individual actions become disruptive to the quiet enjoyment of other customers and store staff.
- 19. All pets must be on a leash. If you own a pit bull or other bully breed or mix, your dog will be required to be leashed muzzled and controlled by a person 19 years of age or older.

## **Parental Escort Policy**

Anyone under the age of 17 must be accompanied and in the presence of an adult (25 years or older) after 9:00 p.m. A valid state or school-issued identification card may be required to verify age.
